The [South Carolina Osteopathic Medical Society](#) (SCOMS) is accepting posters for presentation at [the 2025 SCOMS Winter CME Conference](#) at the AC Hotel By Marriott Greenville in Greenville, SC. This event will take place from February 14-16, 2025. Case reports, original research, and Quality Improvement (QI) projects are eligible for submission. **Fifteen (15) presentations will be accepted for the conference.**

This is an opportunity to share your case study or in-progress scholarly research or improvement project and receive feedback from professionals in the field. This is an excellent opportunity to revise and enhance your work for presentation at other meetings.

### **About the Call**

Submissions should further the mission of SCOMS purpose and the medical community as a whole:

- **Purpose:** SCOMS seeks to improve and promote public health by the advancement of the science and profession of osteopathic medicine; to collect and disseminate information of professional interest and value to members of this Society; and to elevate and maintain the standards of the Osteopathic profession in the state of South Carolina.

### **Diversity, Equity, and Inclusion**

Authors are asked to consider both the impact of their proposed topic on underrepresented and underserved populations as well as the relevance of the topic to the conference attendees. Accordingly, students and residents are encouraged to address issues of cultural humility/sensitivity in their poster presentations. When applicable, presenters are encouraged to describe how issues of cultural diversity and inclusion are considered in their specific aims or session narrative. Proposals from all specialties and medical school years are encouraged.

- Submissions should not contain any information that could personally identify a patient or staff member, or any identifying geographical or facility names.
- Applicants whose submissions are accepted will be expected to register and attend the SCOMS 2025 Winter CME Conference in Greenville, SC.

## Scholarly Poster Presentation

- A visual poster presentation specifically designed for students, residents, and fellow investigators to gain the opportunity for broad interaction and feedback regarding their scholarly works in progress. Original research may be clinical, educational, or biomedical. Submissions from the following categories are permitted:
  - Clinical Research
  - Quality Improvement/Performance Improvement
  - Educational/Simulation Research
- The following professionals are encouraged to submit a scholarly work in progress:
  - Medical Student
  - Resident
  - Fellow

## Submission Instructions

**Posters must be submitted to [tammy@scdos.org](mailto:tammy@scdos.org) by 9:00 p.m. on Monday, December 2, 2024.**

Fifteen (15) posters will be selected for presentation at the Conference. Authors will be notified of acceptance via email on December 13, 2024. One (1) Fellow, Resident or Student (preferably the first author) per poster will be permitted to present in person at the Conference.

## Poster preparation criteria:

- The SCOMS display boards are **40 inches high x 60 inches wide**. For the best display, posters should not exceed the size of the board.
- The Abstract should be placed in the upper left-hand corner of the poster underneath the title and author blocks that should be displayed across the top border of the poster.
- Recommended sections of the poster should include:
  - Abstract
  - Introduction, Experimental Design or Methods
  - Results
    - Tables, figures, illustrations, photographs, and other graphic elements may be included.
  - Conclusion
  - References
    - A QR code with link to a References document may be utilized to save poster space.
  - Acknowledgements for any funding source(s), institutional support, or individuals who have contributed significantly but who are not listed as authors.

## Review and Notification


All submissions will be reviewed by members of the SCOMS Poster Presentation Committee and will be evaluated on the following:

- Adds to existing knowledge or presents an innovative/cutting-edge topic
- Has significance/importance/relevance to osteopathic medicine
- Scientific/clinical content is valid and supports the conclusions
- Likelihood of results by the time of the SCOMS 2025 Winter CME Conference
- Methods well written and presented
- Clearly organized, logical flow, no spelling or grammatical errors
