Jeff Cashman, MS, DO, FACOFP

Ryan Hakimi, DO, MS, NVS, RPNI, CPB, FNCS, FCCM, FAAN

Dr. Hakimi is Board-Certified in Neurology (AOA), Neurocritical Care, Neurosonology (Registered Physician in Neurovascular Interpretation-RPNI, a Neurovascular Specialist (NVS), and a Certified Professional Biller (CPB). He is the first fellowship trained DO Neurointensivist and the first DO to be designated Fellow of Neurocritical Care Society. He received a Presidential Citation in 2014, 2017 and 2018, and 2020 from the Neurocritical Care Society and in 2017 from the Society of Critical Care Medicine. He is the current president of the American Society of Neuroimaging.

Dr. Hakimi is the Director of Transcranial Doppler Ultrasound Services and the Chair of Pharmacy and Therapeutics at Prisma Health-Upstate in Greenville, SC. He serves as a Professor at the University of South Carolina-Greenville School of Medicine. He is a Certified Professional Biller and is Certified in Advanced Neurology and Neurosurgery Coding.

Dr. Hakimi wrote the post-cardiac arrest hypothermia protocols for Durham County EMS (North Carolina) and later worked with the Oklahoma Office of the Medical Control Board to co-author the state's post-cardiac arrest treatment protocol, which was applied throughout the state. He served as the Vice Chair of the LifeShare Advisory Board (Oklahoma Organ Transplantation Services) from 2010-2013. He co-authored the Continuum article on the "Neuroimaging of Hemorrhagic Stroke."

He has a Master of Science in Radiological Health from the University of Michigan-Rackham Graduate School and is a graduate of Michigan State University College of Osteopathic Medicine. Dr. Hakimi completed a Neurology Residency at Michigan State University-Botsford Hospital and a two-year Neurocritical Care and Stroke Fellowship at Duke University Medical Center. He was a United States Department of Energy Applied Health Physics Fellow. Dr. Hakimi is a Physician Trustee and Past President of the South Carolina Osteopathic Medical Society.

She initially worked in the Emergency Department at MUSC Kershaw and currently serves as an attending physician in Urgent Care at LMC Northeast, signifying a gradual shift toward a less demanding professional schedule.

Throughout her career, Dr. Hammock has maintained a profound commitment to GME, encompassing the mentorship of medical students, residents, and new attending physicians. This dedication stems from the belief that teaching not only facilitates the transmission of knowledge but also encourages exposure to diverse perspectives and enhances understanding. She completed a transitional internship at The Union Memorial Hospital and a Residency in Anesthesiology and Critical Care Medicine at the Johns Hopkins Hospital in Baltimore Maryland where she was Chief Resident. She stayed on as Faculty at The Johns Hopkins School of Medicine for two additional years before joining a private practice Anesthesiology group.

In 2008, Dr Hanley contracted necrotizing fasciitis of her right hand and arm. She lost most of the functional use of her right hand and was unable to practice as an anesthesiologist. After more than 20 surgeries, she began a Residency in Family Medicine at Kent County Hospital in Warwick, RI. Upon completion of this program, she stayed on and did a one-year Fellowship in Undersea and Hyperbaric Medicine and wound care also at Kent.

She then stayed and ran the Fellowship at Kent until she relocated to Charleston, SC in 2018 to take over as Medical Director of the Wound, Vascular and Hyperbaric Medicine program at Roper St. Francis Healthcare. She has grown this program from one site to 3 different clinics and will be opening a new center in 2025 and another in 2026.

Dr. Hanley is a national and internationally known speaker, author and consultant for wound care and hyperbaric medicine. She is a passionate advocate for her patients and her profession. She is board certified in Family Medicine, Wound Care and Hyperbaric Medicine. She has also served as the Associate Vice Chair of Clinical Affairs and Operations for the Department of Emergency Medicine over the last two years. Dr. Osinubi is the Director for Clinical Services at NJ WRIISC. In this position she leads the NJ WRIISC Clinical team in providing excellence in post-deployment health evaluation services to our Nations' Veterans with deployment-related health and exposure concerns and assists VA clinicians in delivering the highest quality care to this unique group of Veterans.

Dr. Osinubi is a board certified Occupational and Environmental Medicine physician with additional certifications in Integrative Health and Functional Medicine. Prior to joining the WRIISC, she was on Faculty at the University of Medicine and Dentistry of New Jersey (now Rutgers University) – School of Public Health and was the Associate Director of the residency program in Occupational and Environmental Medicine. At the Environmental and

Occupational Health Sciences Institute (EOHSI), she directed the Information Toxicology Project funded by the New Jersey Department of Health and Senior Services. There, she led the team that wrote the medical toxicology and health effects sections for approximately 1,400 hazardous substances fact sheets, which are part of the New Jersey Right to Know program for hazardous chemicals in the workplace.

Dr. Osinubi has worked with the WRIISC since 2008 and has established herself as a national expert in the exposure concerns of deployed Veterans. Dr. Osinubi provides consultations to Veterans and/or their health care providers on matters relating to complex medical health conditions and exposures of concern during military service. She takes a leading role in educating both the VA provider community and Veterans on exposures from various deployments and the potential for health effects. She is part of the WRIISC team that trains clinicians on deployment-related exposures at conferences across the Nation. Dr. Osinubi also co-founded the Airborne Hazards Center of Excellence within the WRIISC to comprehensively examine Veterans with cardiopulmonary symptoms and exposure concerns related to poor air quality and potentially toxic respiratory contaminants during their military deployments.

Dr. Osinubi's past professional experience enhance her current WRIISC leadership role and more importantly, allow the WRIISC clinical team to develop innovative services that will help to improve the clinical care of Veterans with post-deployment health and exposure concerns.

Nicholas Pennings, DO, DABOM, MFOMA, FACOFP, FAAFP

Dr. Pennings is a Professor and Chair of Family Medicine at the Campbell University School of Osteopathic Medicine, where he also serves as Director of the Campbell University Health Center. In this role, he oversees clinical operations while teaching clinical skills and primary care topics, with a strong focus on nutrition and obesity education.
