What DOs Should Know About the Physician Fee Schedule Final Rule

On Nov. 1, 2024, the [Centers for Medicare & Medicaid Services](#) (CMS) issued the CY2025 Medicare Physician Fee Schedule Final Rule, which includes updates to physician payment policies, the Quality Payment Program (QPP) and Medicare Shared Savings Program (MSSP).

The AOA has developed an [in-depth guide](#) outlining key changes that could impact physician practices in 2025. Highlights from the AOA's guide include:

- Discussion of the Medicare conversion factor reduction and efforts to mitigate payment cuts in 2025
- Updates to payment for E/M services and advanced primary care that support coordinated, longitudinal care
- Changes to Medicare telehealth policies that support continued payment and access
- Updates related to 90-day global surgical payments
- Changes to the QPP, including Merit Based Incentive Payment System (MIPS) scoring changes for 2025

2024 State of Lung Cancer Report

The [American Lung Association](#) recently released its [2024 State of Lung Cancer Report](#), which found South Carolina still does a little better than average at getting patients low-dose CT scans that can help catch it early, but survival in the Palmetto State still lags the U.S. average. In fact, this year's five-year survival rate of 25.5 percent is slightly above than last years of 24.4 percent, but both are below the national average of 28.4 percent, said Danna Thompson, ALA advocacy director for South Carolina. There also are discrepancies in outcomes, with Hispanics among those who are least likely to receive lung cancer treatment, she noted. [Read the story in the Post & Courier.](#)

AOA Physician Services Billing/Coding Hot Tip



When physicians perform an evaluation and management (E/M) service on the same day as a minor procedure, applying modifier -25 is essential to indicate that the E/M is a distinct and separate service. Despite proper coding, many private payers blanket deny these claims, often due to automated algorithms that flag modifier -25 claims for review by a nurse, coder, or physician. These reviewers consider factors like the physician's record of appeals—if a provider seldom appeals denials, it can suggest inappropriate billing, increasing the chance of future denials.

However, a high rate of successful appeals signals appropriate billing and improves the likelihood of claims being overturned and paid. Nearly 60% of these blanket denied claims are ultimately approved

on appeal. Physicians should ensure their documentation clearly supports modifier -25 use and appeal unjustified denials, as not appealing can impact future claims and revenue.
