## Tommy G. Lindsey, II, DO, FACOS, CHSE

Dr. Lindsey is a Board-Certified General Surgeon with 23+ years of experience practicing as a rural surgeon, mostly in Ruidoso, New Mexico, where he was often the only general surgeon available in an 80-mile radius and took solo call 24/7 months on end. The New Mexico Governor appointed Dr. Lindsey as Chairman of the New Mexico Osteopathic Board of Medical Examiners where he served for eight years. President Bush appointed him as Commissioner of the United States/ Mexico Border Health Commission from 2003 to 2010.

Dr. Lindsey is the Associate Dean for the Center for Simulation & Technology, SC. Prior to VCOM, he served as Assistant Professor of Surgery at the Michigan State University-College of Osteopathic Medicine and was a General Surgeon in Michigan, New Mexico, and South Carolina. He served as Chief of Staff at Hayes-Green-Beach Hospital in Charlotte, MI; Mimbres Memorial Hospital in Deming, NM, and Lincoln County Medical Center, Ruidoso, NM.

Dr. Lindsey received his medical degree from Michigan State University-College of Osteopathic Medicine, completed his Rotating Internship at Lansing General Hospital, and completed the Michigan State University Consortium General Surgery Residency at the Michigan Capital Medical Center. He is the President of the South Carolina Osteopathic Medical Society for 2022-2023.
